Last March 11, the Alumni of Marist Brothers' High School in Fiji paid a visit to Mulivai Community to thank the brothers. It began with an Ava ceremony, a Fijian tradition, followed by dinner. The alumni who visited the community are living and working in Samoa for a long time now. They were also joined by family members. The visit was initiated by Mr. Adrian Fidow, eldest brother of Br. Anitelea, who is an alumnus of St. Joseph's College.

February 15 was the start of my Pastoral Experience as part of my second year Novitiate program. It takes place in Mapuifagalele; in samoan language, it means home for the elders or rest homes.

It was founded in 1970 and is under the administration of the Little Sisters of the Poor. Mapuifagalele is in the village of Vailele, Apia, Samoa. I go there thrice a week from Monday to Wednesday from 8:30 AM to 1 PM. Every Thursdays of the eight-weeks experience is spent in Marist Brothers' Primary School where I teach remedial reading. It is an experience for myself to do Pastoral care and to deepen my faith and my understanding of religious life.

CONTRACT BETWEEN THE BISHOP OF JOLO AND THE MARIST BROTHERS¹



KNOW ALL YE WHOSE PRESENTS THESE COMETH:

The Most Reverent FRANCIS JOSEPH MCSORLEY, OMI, D.D., Titular Bishop of Sozusa in Palaestiana, Vicar Apostolic of Jolo in the Philippines, administering the temporal possessions of his diocese and providing for the religious education of his whole flock; in recognition of these duties and in the exercise of his powers of jurisdiction, has consented, agree and covenanted with the MARIST BROTHERS OF THE SCHOOLS IN THE PHILIPPINES, a religious non-stock educational corporation existing under the laws of the "Republic of the Philippines, represented herein by the Reverend Brother MAURUS JAMES JOSEPH DOHERTY, FMS, as Provincial Visitor in the Philippines, on the transfer, of the administration, disciplinary and academic supervision and control of the NOTRE DAME OF JOLO HIGH SCHOOL within the Diocese of Jolo, in accordance with the stipulations and covenants, to wit: -

1. Notwithstanding the provisions of existing agreement, if any, for the academic school year 1959-

1960 the MARIST BROTHERS OF THE SCHOOLS IN THE PHILIPPINES (MARIST BROTHERS) shall take over the direction, supervision, known as the NOTRE DAME OF JOLO HIGH SCHOOL. The school after the transfer shall then be under the direct supervision and control of a Brother Director who upon his assumption as such shall have under his control the finances of the school.

- 2. Upon the effectivity of this Agreement, the employment and/or dismissal of teachers for the academic school year 1959-1960 shall be the prerogative of the Brother Director which will be exercised only upon previous consultation with Rector of the College and the Superior of the Presentation Sisters. Provided; that should there be need for the services of a Brother to teach in the College, the latter shall first secure the prior permission of the Provincial Visitor of the MARIST BROTHERS.
- 3. The construction and erection in a site chosen by, of a Boys Department High School and a Brothers' Residence both in accordance with the plans and specifications of, the MARIST BROTHERS shall be undertaken by the Bishop at his own expense including the furnishings of the Brothers' Residence which shall be patterned after the Bishop's House, both of which shall become the properties of the MARIST BROTHERS together with all the equipment, and personal properties found therein.
- 4. Notwithstanding the provisions of Paragraph 1 hereof, upon the advent of the academic school

year 1959-1960, the MARIST BROTHERS retaining the full and complete ownership of the school and Brothers' Residence, with its equipment and furnishing, shall take over EXCLUSIVELY the administration, supervision and control of the NOTRE DAME OF JOLO BOYS' DEPARTMENT HIGH SCHOOL.

THIS AGREEMENT shall govern and prescribe the relationships between the Reverend Parties herein during the transitory period from the academic school year 1959 to 1961 when the drawing of a new agreement shall be undertaken reiterating therein the provision regarding the ownership of the school, equipment and the like, the Brothers' Residence as provided by the Bishop and the registration in the name of the MARIST BROTHERS of the title of the land on which the school and residence are erected. PROVIDED; new agreement will not in any manner render the efficaciousness of this Agreement which is binding and valid until superseded.

DONE IN THE DIOCESE OF JOLO, Philippines, this 2nd day of February, of the year of our Lord, 1959.
